Whereas, it is necessary to ensure that the Endowment attain the objective and mission of its establishment effectively; and to make its activities to be closely followed and controlled by Oromia Regional State Public Enterprises Regulatory Authority;

Now, therefore, in accordance with Article 49 sub Article (3) (a) of the Oromia Region Revised Constitution, Proclamation No. 46/2001, it is hereby proclaimed as follows:

1. Short Title

This Proclamation may be cited as "**Tumsa Endowment Accountability Proclamation No. 225/2020.**"

2. Definition

Unless the context require otherwise, in this proclamation:

- 1) "Authority" means Oromia Regional State Public Enterprises Regulatory Authority;
- 2) "Board" means the management Board of Tumsa Endowment for the Development Of Oromia established in accordance with the Endowment's establishment regulation;
- 3) "Endowment" means Tumsa Endowment for the Development of Oromia established in accordance with Organizations of Civil Societies Proclamation.
- 4) "Government" means Oromia Region Government.

3. Scope of Application

This proclamation shall be applicable to all social and economical development activities that Tumsa Endowment undertaken by itself and the shares that the Endowment holds in other organizations.

4. Accountability of the Endowment Without prejudice to its organizational set up and structure, the Endowment shall be accountable to the Authority.
5. Patron of the Endowment The Patron of the Endowment shall be the President of Oromia Regional State.
6. Power and Duty of the Authority Without prejudice to the power and duties given to the Authority by other laws, the Authority shall have the following power and duty for the implementation of this proclamation: 1) Follow up chiefly; control the Endowment; 2) Examine and approve the short, medium and long term plan prepared and submitted to it by the Board; 3) Evaluate the overall activities and audit performance reports submitted to it by the Board periodically; give direction; 4) Follow up the Endowment depending on its work nature; establish the system for its follow up.
7. Providing Support The Government Administration, Government Institutions and the Authority shall provide financial, technical and professional support for the Endowment to attain the objective and mission for which it is established.
8. Inapplicable Laws Any proclamation, regulation, directive and work practices inconsistent with this proclamation shall not be applicable on matters covered under this proclamation.
